INFORMATION ON CRS

Voluntary pension funds in countries adopting common reporting standards (hereinafter: "CRS"), including Aegon Magyarország Önkéntes Nyugdíjpénztár (Aegon Hungary Voluntary Pension Fund), are required to collect and report certain information on the status of the tax residence of Fund Members. Please note that in connection with automatic tax information exchange and common reporting regulation, pursuant to Act CXC of 2015 on the promulgation of the multilateral competent authority agreement on automatic exchange of financial account information, Act XXXVII of 2013 on the rules of international public administration cooperation related to taxes and other public duties, and Act CXCVII of 2015 on the amendment of certain acts, Aegon Magyarország Önkéntes Nyugdíjpénztár is required to conduct a tax residence identification of Fund Members and to report certain financial data indicated in the statement or other data prescribed by law, referring to your voluntary pension fund account, to the National Tax and Customs Administration of Hungary. At the same time, local tax authorities share the reported data with the tax authority (authorities) of the country (countries) in which you are a tax resident.
